

## Warranty & Terms & Conditions

The dFENCE Units are warranted to be free from material and manufacturing defects for 12 months from the date of issue to the individual user, as verified by the warranty card.

If the dFENCE Unit has a manufacturing or material defect, as determined through inspection by an authorized dFENCE representative, the dFENCE Unit will be repaired or replaced at no cost to the customer.

The dFENCE Unit Warranty shall be void if the product has been altered, abused, or misused, stored improperly, or not used in accordance with users instructions.

Should the dFENCE Unit ballistic panels be compromised or damaged it should not be used and should be immediately returned to the manufacturer for inspection and repair. If the damage is the result of improper care, storage or abuse, attack, determined solely by dFENCE, then dFENCE will advise the owner of recommended repair or replacement costs

**This warranty does not cover and is void for and all liability for injury or death shall be avoided where :**

- Any dFENCE Unit being altered or modified in any way other than by dFENCE authorized factory alterations.
- Any ballistic element that has been altered or modified in any way other than dFENCE authorized factory alterations.
- Damage as a result of abuse or misuse.
- Damage as a result of improper storage or maintenance.
- Penetrations as a result of armour piercing ammunition, calibers, weapons or ammunition types not specified explosives, sharp instruments and similar attacks.
- Injury as a result of bullets or other projectiles specified or not specified, or other instruments impacting the dFENCE Unit ballistic or non ballistic areas;
- Injury during moving or deploying the dFENCE Unit to its defensive position or where the dFENCE Unit is dislodged from its defensive position;
